1. Welcome and introductions

The Chairman, Lesley Belcher, warmly welcomed members to the meeting and conference. She particularly welcomed new Management Committee members Clare McArdle, Tim Sunter and Sue Dixon who had joined since the last AGM.

She gave a full overview of ART activities in 2019. The presentation is available on SmART Ringer, highlights of which are:

- ART ran 64 courses (M1 39, M2 25) in 2019
- 156 teachers were accredited in 2019
- 890 new ringers were registered on Learning the Ropes
- 1,191 LtR Certificates were issued in 2019
- ART now has 650+ Members

Membership

Membership of The Association is offered to all those who are accredited to teach bell ringing under the ART Training Scheme and to those who act as Tutors for the scheme. Those who have completed a single Module of the Training Scheme are eligible for Associate Membership and those completing both Modules can be Full Members. A small number of persons with particular skills or expertise are offered Affiliate Membership by the Management Committee.

Management

Policy and executive decisions are made by the Management Committee. The Committee is elected from the membership at the Association's Annual General Meeting. The officers and trustees are appointed by the Management Committee. A business plan is produced annually and regularly reviewed at meetings of the Committee.

Relationship with other ringing bodies and the ringing community

ART has strong working relationships with other ringing bodies, notably the Central Council of Church Bell Ringers (Reg'd Charity No. 270036) and the Ringing World (Reg'd Charity No. 287182). Regular meetings take place with these and other ringing organisations. There is extensive promotion and organisation of Training Scheme Day Courses and Workshops.

Risk Analysis

The Association has recently conducted a comprehensive risk analysis of its activities and is putting measures in place to mitigate the risks faced wherever possible.

OBJECTIVES AND ACTIVITIES

The objects of the charity are: **To develop and support the delivery, integrity, and standards in teaching, instruction and education of the art of change ringing.**

In pursuit of these objects ART undertakes the following activities:

- Developing and delivering instruction schemes for teaching the art of bell ringing
- Having a system of accreditation for those that achieve and maintain the standards set
- Setting and maintaining a clear set of standards for teachers
- Working with other bodies where appropriate to achieve our goals
- Developing and delivering a structured scheme for learning which recognises achievement
- Providing support and facilities for new ringers to encourage and motivate
- Having a code of practice for accredited teachers
- Arranging seminars, workshops and learning opportunities for teachers
- Providing continuous support and facilities to encourage teachers to develop the quality and quantity of their teaching activity



- Developing the ability of teachers to work together to support group teaching and developing centres of excellence
- Assisting and supporting teachers with recruitment
- Providing support and facilities for new ringers to encourage and motivate
- Motivating and encouraging teachers to train and enthuse new ringers
- Maintaining websites for teachers and learners including interactive learning
- To improve the learning experience and increase the retention rate of learners

Our key mission is to maintain the quintessentially English art of ringing changes on church bells and hand bells by training ringers for the future.

Staff and Volunteers

The Association employs two part-time paid Administrators. All the trustees are volunteers and none receives any remuneration, other than expenses, for their work. Other volunteers assist the Association in its work through the provision of advice on matters such as recruitment, information technology, communications, fundraising, running its merchandising arm and helping the Administrator.

COVID AND BELL RINGING

Like many other charitable organisations in 2020, ART has been adversely affected by the Covid crisis. The social distancing rule has prevented any face-to-face courses or bell ringing training since mid-March and bell ringing has all but ceased as the various Tiers of lockdown have been implemented. At the time of writing it is anybody's guess when tower bell ringing and training may resume, but we have clear plans in place to enact when the time is right.

ART are also working with the CCCBR to deliver the Survival and Recovery strategy.



FINANCIAL REVIEW

Despite a very challenging year in which ART's income from events was reduced by almost 90%, the main activities showed a surplus of £223 mainly due to the continued support of our sponsors and members and backdated Gift Aid receipts. Merchandising, though similarly impacted by the pandemic, achieved a profit of £1,713.

The Trustees consider it necessary and in the best interests of ART to maintain a balance of 'free' unrestricted funds which have not been committed or designated for a particular project. This reserve fund is required to enable the organisation, in the short-term, to maintain ongoing services and enable financial commitments to be fulfilled and is estimated to be a minimum of £20,000.

ACHIEVEMENTS AND PERFORMANCE – REVIEW OF 2020

- 8 courses were held during 2020 (64 in 2019):
 - Module 1 4 courses (39 in 2019)
 - Module 2 1 M2F 3 M2C (15 M2F, 10 M2C in 2019)
- 71 teachers attended day courses in 2020 (569 in 2019).
- 34 teachers were accredited in Q1 2020 (M1:22 M2F:20 M2C 6) (156 in 2019).
- 294 new ringers were registered in the Learning the Ropes scheme in 2020 (890 in 2019).
- 302 LtR certificates were issued during 2020 (1,191 in 2019)
- The total number of course delegates who have attended ART courses since the start is 3,996 (3,925 as at 2019)
- The total number of ringers registered on SmART Ringer since the start is 6,287 (5,993 as at 2019).
- 12 workshops were run in 2020 (11 in 2019). These were all online workshops.
- Over 250 users have registered for a range of online courses.
- The Annual Conference took part in March 2020 with approx.100 delegates attending.
- ART WORKS continues to be published for the benefit of ringing teachers.
- Tower Talk continues to be published for the benefit of all ringers on the Learning the Ropes scheme.
- Awards were presented at the conference with sponsored cash prizes.
- Plans are in place to upgrade ART IT systems and the SmART Ringer website.
- Sales of ART products were £5,662 in 2020 (£14,152 in 2019).
- The continued financial contributions of our Supporters have provided a firm financial base.

Independent examiner's report to the trustees of The Association of Ringing Teachers (ART)

I report to the trustees on my examination of the accounts of the Association of Ringing Teachers (The Trust) for the year ended 31st December 2020.

Responsibilities and basis of report

As the charity's trustees, you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').

I report in respect of my examination of the Trust's accounts carried out under section 145 of the 2011 Act, and in carrying out my examination I have followed all the applicable Directions given by the Charity Commission under section 145(5)(b) of the Act.

Independent examiner's statement

I have completed my examination. I confirm that no material matters have come to my attention in connection with the examination giving me cause to believe that in any material respect:

- (1) accounting records were not kept in respect of the Trust as required by section 130 of the Act; or
- (2) the accounts do not accord with those records; or
- (3) the accounts do not comply with the applicable requirements concerning the form and content of accounts set out in the Charities (Accounts and Reports) Regulations 2008 other than any requirement that the accounts give a 'true and fair' view which is not a matter considered as part of an independent examination.

I have no concerns and have come across no other matters in connection with the examination to which attention should be drawn in this report in order to enable a proper understanding of the accounts to be reached.

Proposed changes to the ART Constitution

For consideration at the ART Annual General Meeting on Saturday 6 March 2021

BACKGROUND

Several issues require changes to the ART Constitution. Particularly the link to the CCCBR where ART needs to react to their changes. Also, the position of Trustees needs to be properly dealt with in the constitution. Some tidying up of the 'Objects' wording is proposed for clarity as well as the ability to support initiatives through grants if appropriate.

Objects

The wording has been simplified and includes all that was there before, but also mentions recruitment and standards. ART has supported both in many ways since it was formed.

Powers

This now includes the ability to give grants to support ART's aims, if appropriate. Whilst we have found ways of supporting a few initiatives in Teaching and Recruitment this now formalises ART's ability to do that. It also recognises ART's work and contribution through awards. These areas were not envisaged when ART was formed.

Link to the Central Council

The current constitution requires a member of the Management Committee to represent ART and be a member of the Council's Volunteer and Leadership Workgroup. It is likely that the Council's Executive will seek to reorganise its workgroups from time to time. It is therefore proposed to remove this requirement from the ART Constitution and replace it with a separate partnership agreement with the Council.

Trustees

The current Constitution is largely still the same as that agreed on the setting up of the Association in 2012. Since then, ART has become a registered charity and is required to have trustees. The ART trustees have until recently been the same individuals as the members of the Management Committee, the only exception being where an individual has been deemed to have a potential conflict of interest. More recently non-executive trustees have been appointed who are not voting members of the Management Committee. There is currently no provision in the Constitution to define the role, number, means of appointment or requirement to meet of these trustees. It is proposed that going forward the trustees will be a smaller group which can meet separately if required and with a specific remit to have oversight of the governance of the Association.



THE CHANGES PROPOSED

The Management Committee recommends that Members approve the following changes:

"Objective"

Delete:

to advance education and training in bell ringing particularly but not exclusively by providing workshops and accredited courses on bell ringing and supporting bell ringing projects as a way of supporting the development, the skills, practice and art of change ringing on tower and handbells and raising public awareness of all aspects of bells and bell ringing.

Insert:

to advance recruitment, education, and training in bell ringing, particularly but not exclusively by:

- Developing and providing Information and Training.
- Supporting projects and events to recruit, develop skills and share good practice in the art of ringing on tower and hand bells.
- Supporting the recruitment of new ringers.
- Setting, regulating, and encouraging improved standards for teaching.
- Raising public awareness of all aspects of bells and bell ringing.

"Powers"

Insert new power 13:

13. Make grants to support appropriate schemes and initiatives, and to give awards to recognise achievement.

Renumber power 13 as 14:

To take any form of action that is lawful, which is necessary to achieve the objective of the Association.

"Management Committee"

Delete:

10. One member of the Management Committee shall represent and be a member of the Central Council Volunteer and Leadership Workgroup.

Insert:

10. The Management Committee shall recommend nominees to be appointed as Trustees by Members at the AGM. The Trustees will maintain an oversight of the governance of the Association as specified in the section "Trustees" below.

New section "Trustees" [to follow "Officers"]



- 1. Trustees of the Association shall be appointed annually at AGM of the Association. The Association Chairman, Secretary and Treasurer will be ex-officio trustees.
- 2. There shall be a minimum of five Trustees and no more than seven including the ex-officio Trustees.
- 3. Trustees will have an oversight of the governance of the Association with particular responsibility for ensuring that:
 - The Association is carrying out its purposes and benefitting the public.
 - It is complying with its constitution and with charity and all other applicable law.
 - It is managing its resources responsibly.
 - It is accountable to legal requirements and to its members.
- 4. Trustees shall serve for no more than ten (10) consecutive years. A year's break must be taken before they can be considered for a further period of service.

"Meetings"

Add new section 4:

- 4. Trustees
 - a. Trustees shall be given at least twenty-one (21) days' notice of the date and place of any meeting due to be held.
 - b. A quorum of four (4) trustees shall be present for a meeting to take place.
 - c. Trustees will meet on a minimum of one occasion per year.

APPROVING THE CHANGES

These changes can be approved by a simple majority of members voting at a quorate general meeting of members of the Association.

PUBLICATION

If approved, the new constitution will be published on ART's website.
